This study calculates maximum gross and net revenue for delivering APT with 8 pumps, 2 or 3 session/day, 25 days/month, at the average Medicare reimbursement rate of \$415 per treatment. Broadly speaking, 85% of APT treatments are administered to Medicare patients. The study does not include expenses related to clinic operations, space, and marketing, as these expenses may vary significantly among providers.
